CITY OF MABEL PERMIT APPLICATION

GOLF CARTS, MINI TRUCKS, ALL-TERRAIN VEHICLES (ATVs), UTILITY TASK VEHICLES (UTVs)

- Permits are valid for a single calendar year (May 1st through April 30th) and the cost is \$15.
- No one under the age of 16 may operate golf carts, mini trucks ATVs or UTVs on streets, alleys or rights of way, not even with an adult in the passenger seat. Ignoring this requirement of a legally adopted City of Mabel Ordinance may invalidate owner's liability insurance in case of an accident.
- Permits will not be issued to anyone under the age of 16.
- Permits will not be issued to applications who have had their state-issued driver's license revoked as the result of criminal proceedings.
- Golf carts must display a slow-moving vehicle emblem on the rear of the vehicle.
- All vehicles must have a rearview mirror.
- The number of occupants on the golf cart, ATV, UTV, or mini truck may not exceed the design occupant load (one person per seat).
- Occupants of the golf cart, ATV, UTV, or mini truck are prohibited from standing while the vehicle is in motion.
- Hours of operation are sunrise to sunset unless equipped with manufacturer installed lights front and rear.
- Vehicles may not be operated during inclement weather or during conditions of low light unless properly lighted.
- Vehicle use is not permitted while under the influence of intoxicating liquor or narcotics or habitforming drugs.
- Golf carts, ATVs, UTVs, and mini trucks must visibly display a current city-issued permit on the rear
 of the vehicle.

NOTE: Golf carts, ATVs, UTVs, and mini trucks are permitted to operate only on city streets, not state or federal highways, except to cross at designated intersections.
